Emulsogen LCN 088 is used as a wetting agent for industrial applications in aqueous solutions of 1 - 5 g/l and as dispersing agent in paints and coatings for fillers and pigments in concentrations of 0,1 - 1,0 %.

Emulsogen LCN 088 is used as emulsifier for O/W - emulsions of oils, fats, silicon oils and polyolefin wax emulsions in concentrations of 5-10 % and for emulsion polymerization in recommended levels of 1 - 2 % based on monomers.
